# OFFICIAL CONTEST RULES FOR WSBG, WPCO & WVPO hereinafter referred to as the "Stations"

#### 1. Promotion Dates.

The Stations, owned and operated by Seven Mountains Media (7MM) is running a stations promotional contest weekdays from Thursday, December 5, 2024 starting at 12:00am EST through Friday, December 20, 2024 at 11:59pm EST (the "Promotion Dates").

## 2. Entry / How To Win / Eligibility

- a. Log onto 935sbg.com, poco103.com or bigfootpoconos.com during the Promotion Dates to enter the keyword and register to win the daily prize pack each weekday December 5, 2024 through December 20, 2024.
