93.5 SBG’s Summer 2020 Contest
OFFICIAL CONTEST RULES
FOR WSBG hereinafter referred to as the “Station”

1. Promotion Dates.

Qualifying Period: The Station, owned and operated by Seven Mountains Media (7MM) is running a station promotional contest with the qualifying period starting on Thursday, July 9, 2020 at 12:00 AM EST and concluding on Friday, July 31, 2020 at 6:00 PM EST. (the “Promotion Dates”).

2. Entry / How To Win / Eligibility

a. Listen during the Promotion Dates for the cue to text in the keyword each weekday July 9, 2020 through July 31, 2020 between 10AM and 6PM to 570-424-WSBG, (570-424-9724). One random listener will win one (1) one of the daily prizes. The cue to text will occur twice each weekday during the promotion dates. One (1) \$25 gift certificate will be awarded each weekday from either Shear Brilliance or Miller’s Paint & Wallpaper during the Promotion Dates and be qualified to be in the running to win a week’s stay from August 8, 2020 through August 15, 2020 at SBG Beach House. At the time of their winning, each designated winner will be required to provide all information requested, including their first and last name, complete address including zip code, daytime and evening telephone numbers, and their date of birth to be eligible to win. In the event of a tie, duplicate claims, or multiple persons claiming to be the correct caller, a final and binding decision will be made by 7MM, which reserves the right to hold a random drawing in such event to determine the winner.

b. Online: Listeners may log onto 935sbg.com to register to win a \$25 gift certificate and be qualified to be in the running to win a week’s stay from August 8, 2020 through August 15, 2020 at SBG Beach House. Registration dates are starting July 9, 2020 Midnight EST through July 31, 2020 ending at 6:00PM EST. Winners will be notified on August 3, 2020. A total of (7) qualifiers will be chosen from online registrations one (1) \$25 Gift Certificate from a local business and qualify for the Grand Prize drawing to win a week’s stay from August 8, 2020 through August 21, 2020 at the SBG Beach House.

c. The phone number to text when the keyword is given is 570-424-WSBG, (570-424-9724). All texts to any other Station phone number(s) will not be accepted.

d. Contestants listening to the Station via the internet stream are advised that there is a delay between the times the cues to text are made on the air and when they are heard over the internet and therefore will be at a disadvantage over those contestants listening over the air. Listeners to the online stream may not be able to timely participate in any station-conducted on-air contests. Due to this delay in the Station’s streaming broadcast, listeners to the online stream are encouraged to listen to the Station live on-air. No purchase is necessary.

e. Contest is open to all legal U.S. residents. All employees, agents, successors, interns and assignees of Connoisseur Media, LLC, and sponsors of this contest, employees of competing radio stations and members of their immediate families or households are ineligible. The term “immediate family” includes spouses, siblings, parents, children, grandparents and grandchildren, whether as “in-laws” or by current or past marriage(s), remarriage(s), adoption, cohabitation or other family extension and any other persons residing at the same household whether or not related. Participants and winner(s) must be U.S. residents.

f. No “duos”, groups or teams will be allowed to enter together. Any ties, disputes, conflicts, questions or concerns regarding the Contest and/or the prize(s) will be determined by 7MM, whose decision(s) is final.

g. Participants are restricted to the use of ordinary telephone equipment. Participants that enable the “Caller ID” block function may not be allowed to participate unless they enter their correct area code and telephone number. 7MM disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond 7MM’ control, or otherwise. 7MM disclaims all liability for any delays, mis-delivery, loss or failure in the delivery of any item sent by mail, courier, express, electronic transmission or other delivery method. 7MM is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant’s ability to participate in the contest, and any injury or damage to entrant’s or any other person’s computer related to or resulting from participating in or downloading any information necessary to participate in this contest. 7MM stations are not responsible for broken telephone connections, busy signals, mis-dials or lost phone calls.

3. Prizes / Acceptance and Delivery of Prize

a. Twenty four (24) qualifiers total - seventeen (17) on-air and seven (7) online registrants will receive a \$25 gift certificate from either Shear Brilliance or Miller’s Paint & Wallpaper. One grand prize winner will be drawn at random from all qualifiers from WSBG and WVPO for a weeklong stay at the Beach House the week of August 8, 2020 through August 15, 2020 valued at \$2700. Dates of the Beach House stay are non-transferable and will result in a forfeit of the prize if not accepted. The rental lease agreement will be transferred to the winner once chosen. The maximum occupancy of the Beach House is 8. In the event that the winner will not be able to use the Beach House during the reserved time, another one will be chosen at random.

b. All prize(s) must be accepted as awarded. All prize(s) are non-transferable. Inability to accept or deliver prize(s) will result in forfeiture. 7MM retains the right to substitute prize(s) with other prize(s) of equal or greater value in the event the original prize(s) offered is not available for reasons beyond the reasonable control of 7MM. Any valuation of the prize(s) awarded is based on available information provided to 7MM, and the

value of any prize(s) will be determined by 7MM, in its sole discretion.

c. All Contest(s)/Prize(s) are subject to Federal, State and local regulations and laws and are void where restricted or prohibited by law. Promotion is governed by U.S. law and is void outside the United States.

4. Conditions of Winning

a. Each winner must provide Station with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Failure to timely provide such information and/or any other reasonably required documentation including, without limitation, a release and affidavit of eligibility, may result in a delay in receiving prize(s) or the forfeiture thereof. Entrants are required to provide truthful information and Stations will reject and delete any entry that it discovers to be false or fraudulent. Stations will disqualify any entry from individuals who do not meet eligibility requirements.

b. Contest winners, agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever remises, releases and discharges 7MM and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s).

6. Indemnity

a. All participants and winners, agree and do hereby indemnify and hold forever harmless 7MM and their agencies, their agents, officers, employees, affiliates and assigns for any injuries, accidents, misfortunes, losses, damages or causes of action arising from or in connection with participation in the Contest and/or acceptance or use of any prize(s).
